

Should any final action, final decision, or vote be required in the opinion of the Commissioners Court with regard to any matter considered in such closed or executive meeting or session, then the final action decision, or final vote shall be either

- (a) in the open meeting covered by the Notice upon the reconvening of the public meeting; or
- (b) at the subsequent public meeting of the Commissioners Court upon notice thereof; as the Commissioners Court shall determine.

Notice is hereby given pursuant to the requirements of section 551.001 ET SEQ., Texas Government Code, that the Commissioners of Zavala County will meet in special session Wednesday, August 8, 2018, at 11:00 A.M. at the Commissioners Courtroom located at 200 E. Uvalde St., Crystal City, Texas.

AGENDA

- 2. welcome the public;
- 3. public comment (no discussion or action) (5 minutes per speaker);

DELIBERATE AND CONSIDER ACTION ON THE FOLLOWING ITEMS:

- consider approving bills and requisitions;
- 5. consider canvassing the 2018 SD 19 Special Election official final results;
- 6. consider hiring a contractor to add a seal coat to court house parking area including painting new parking lines;
- 7. consider hiring a contractor to add a seal coat to County Annex parking area including painting new parking lines;

- 11. closed session: The Commissioners Court will hold a closed session under the Texas Government Code Legal Section -551.074 of the Open Meeting Act, for the purpose of considering the appointment, employment, evaluation, reassignment, salary, duties, discipline or dismissal of a public officer or employee, to hear complaints or charges against a public officer or employee regarding County Judge personnel;
- 12. open session: Action if any on items no. 10 and 11 above;
- 13. commissioner request for future agenda items (No action or discussion may occur during this agenda item); and
- 14. adjourn.

If during the course of the meeting, discussion of any item on the agenda should be held in a closed meeting, the Board will conduct a closed meeting in accordance with the Texas Open Meetings Act, Government Code, Chapter 551, Subchapters D and E, including consultation with counsel under section 551.071 and certain personnel matters under section 551.074. Before any closed meeting is convened, the presiding officer will publicly identify the Section or Sections of the Act authorizing the closed meeting. All final votes, actions, or decisions will be taken in open meeting.
