

For individuals that are 62 and older we offer a free Grant at \$10,000 that does not need to be paid back, and that would assist with Health and Safety Hazards the only stipulation with the Grant is they can't transfer the title of the home or sell the home for the first three years, if they do transfer or sell within the first three years then they would have to pay back. Community Facilities provide loans and grants but majority is going to be Loans as they are hardly and funds within our agency. We also do Local Food Systems; Community Gardens, Food Pantries, Community Kitchens, Food Banks, and a Green House.
