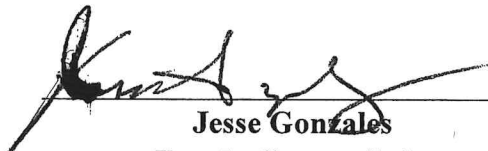
Notice of Open Meeting
