The subjects to be discussed are listed on the agenda(s), which are attached to and made a part of this notice.

If during the course of the meeting covered by this notice, the Commissioners Court should determine that a closed or executive meeting or session of the Commissioners Court is required, then such closed or executive meeting or session as authorized by the Texas Open Meetings Act, Texas Government Code Section 551.001 et. Seq., will be held by the Commissioners Court at the date, hour, and place given in this notice or as soon after the commencement of the meeting covered by this notice as the Commissioners Court may conveniently meet in such closed or executive meeting or session concerning any and all purposes permitted by the Act, including, but not limited to the following sections and purposes:

Texas Government Code Section:

- 551.071 For the purpose of a private consultation with the Commissioners Court's attorney on any or all subjects or matter authorized by law.
- 551.072 For the deliberation regarding real property.
- 551.074 For the purpose of considering the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee, to hear complaints or charges against a public officer or employee.

Should any final action, final decision, or vote be required in the opinion of the Commissioners Court with regard to any matter considered in such closed or executive meeting or session, then the final action decision, or final vote shall be either

- (a) in the open meeting covered by the Notice upon the reconvening of the public meeting; or
- (b) at the subsequent public meeting of the Commissioners Court upon notice thereof; as the Commissioners Court shall determine.

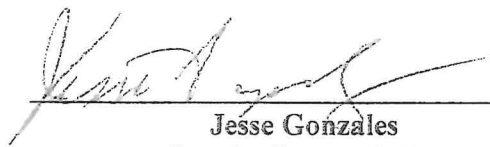
3. Receive a status update and discuss current operations of the Zavala County Disaster Assistance Centers (DACs), including services provided, public utilization, resource availability, agency participation, transition planning, and ongoing recovery operations;

DELIBERATE AND CONSIDER ACTION ON THE FOLLOWING ITEMS:

4. Discussion and possible action to amend the Zavala County Disaster Assistance Center Site Plans and authorize the closure of the Crystal City and Batesville Disaster Assistance Centers effective August 4, 2026, based on substantially reduced public demand, completion of the initial disaster recovery mission, and depletion of available disaster assistance resources, while directing County departments to continue recovery efforts through normal governmental operations as necessary;

5. Discussion and possible action authorizing the County Judge and Emergency Management Coordinator to coordinate the orderly demobilization of Disaster Assistance Center operations, including the return of facilities, equipment, records, and remaining donated resources, and to complete all necessary FEMA and Texas Division of Emergency Management documentation related to the closure of the Disaster Assistance Centers;
6. Discussion and possible action to rescind the Memorandum of Understanding (MOU) between Zavala County and the City of Crystal City for the use of the City's mosquito sprayer during the declared local disaster;
7. Discussion and possible action to authorize the purchase of a mosquito sprayer utilizing the \$10,000 previously allocated under the Memorandum of Understanding with the City of Crystal City, and to authorize the County Judge to execute all documents necessary to complete the purchase;
8. commissioners request for future agenda items
(No action or discussion may occur during this agenda item); and
9. adjourn.

If during the course of the meeting, discussion of any item on the agenda should be held in a closed meeting, the Board will conduct a closed meeting in accordance with the Texas Open Meetings Act, Government Code, Chapter 551, Subchapters D and E, including consultation with counsel under section 551.071 and certain personnel matters under section 551.074. Before any closed meeting is convened, the presiding officer will publicly identify the Section or Sections of the Act authorizing the closed meeting. All final votes, actions, or decisions will be taken in open meeting.
